 - (a) unicycling exposes participants to many risks and hazards ("**Risks and Hazards**"), some of which are foreseeable, some of which are not;
 - (b) as a result of Risks and Hazards, I/we or my/our child as a participant may suffer serious personal injury, even death, as well as property loss;
 - (c) I/we freely and voluntarily assume all Risks and Hazards, and that my or my/our child's Participation is entirely at my/our own risk;
 - (d) no Releasee assumes any responsibility for my safety or the safety of my/our child during the course of Participation;
 - (e) I/we understand that I/we may preview the course and competition area and my/our child's Participation is completely voluntary;
